She provides legal counsel and leads response investigations working with companies IT departments, forensics and vendors to advise on notification, guidance in governmental investigations, mitigation and restoration services. Ms. Ryan counsels clients on development of risk assessment policies, vendor agreement analysis and implementation of data privacy practices. She also aids clients in incident response planning, including table top exercises, assessment of regulatory compliance requirements and inquiries from regulators on both the state and federal levels, and represents clients in litigation focusing on data breaches and data security, information technology, technology failures, implementation of developed software, cloud computing related issues, and IT outsourcing agreements.

She also focuses her practice on the litigation of professional liability matters where she represents health care systems, hospitals, physicians, nurses, dentists and other health care providers in complex cases involving catastrophic injuries. She serves as national counsel for domestic and international companies.
