He continues to train employers and Third Party Administrators on Workers' Compensation issues pertaining to proper claims handling to reduce or eliminate exposure. He also frequently lectures on a variety of other topics including the relationship between HIPAA and the Workers' Compensation Act and the growth of Medicare Set Aside Programs. Mr. Conwell is also a member of the Allegheny County and American Bar Associations.

He received his B.A. from Dickinson College in 1981 in Medieval Studies and his J.D. from University of Pittsburgh School of Law in 1986.
